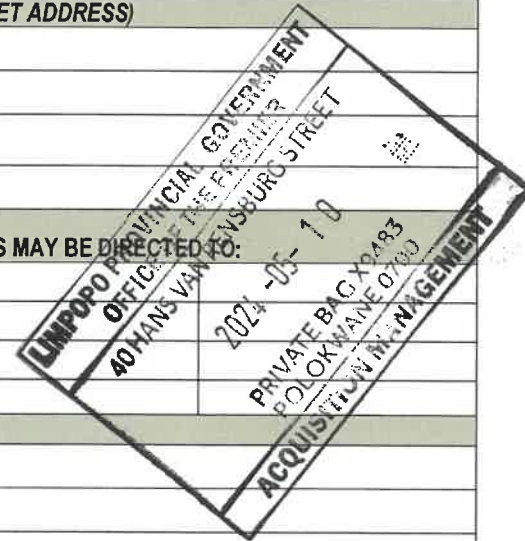

adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

**TERMS OF REFERENCE
FOR PRDP 132/2023-24– PROVISION OF PHYSICAL SECURITY SERVICES IN ALL
BUILDINGS OF OFFICE OF THE PREMIER FOR A
PERIOD OF THIRTY-SIX (36) MONTHS**

1. INTRODUCTION

- 1.1 The Office of the Premier (OTP) in Limpopo Province aims to acquire the provision of Physical Security Services from the Private Security Service provider for the Office of the Premier Buildings which are 40 Hans Van Rensburg Street (Mowaneng Building); 38 Hans Van Rensburg Street; 15A Hans Van Rensburg Street; 41 Church Street; and 40 Paul Kruger Street. The Physical Security services is mainly to safeguard the properties and equipment of Office of the Premier.
- 1.2 The Office of the Premier reserves the right to accept all or part of a bid for the required solution, or not to award the bid at all.
- 1.3 Each statement of requirement, prompt for information, query, or condition in these terms of reference must be responded to by noting the information given and acknowledging that it is understood and agreed to; providing the requested information; answering the query in brief, succinctly and to the point; indicating acceptance or otherwise of the terms; and by providing any supplementary comments as may be necessary.
- 1.4 The bid response layout should be such that each bid clause is reproduced in full and is followed by a reply. The clauses and replies must be distinguishable from each other in style and appearance using a font, colour, borders, and bolding or italics, for example.

- 1.5 Bid documents should be deposited in the tender box situated at the premises of the Office of the Premier, Limpopo at 40 Hans van Rensburg Street, Polokwane, before or on the closing date and time as specified in the Limpopo Tender Bulletin and eTender Portal. All bids, when they are submitted, must be sealed and must bear the official bid number as well as the title of this request for bids on the outside.
- 1.6 This request for bids document contains confidential information regarding the Limpopo Provincial Administration. This information has been provided to furnish potential bidders with the data necessary to provide a holistic response. Non-public information received by any party in connection with the engagement described in this document must be treated as confidential. No part of the contents may be used, copied, disclosed, or conveyed in whole or in part to any party, in any manner whatsoever without the prior written permission of the Office of the Premier. Any reproduction or transmission of information contained in this document except for the sole purpose of responding to this bid is strictly prohibited. References to the Limpopo Provincial Administration must not be made in any literature, promotional material, brochures or sales presentations without the express written consent of the Office of the Premier.

- 2.1 **“Office”** means the Office of the Premier, Limpopo;
- 2.2 **“Preferential Procurement Regulations, 2022”** means the Preferential Procurement Regulations, 2022 issued in terms of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000);
- 2.3 **“PSIRA Act”** means the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), including PSIRA Regulations issued in terms of the Act;
- 2.4 **Security Administrator** is the person appointed by the Office to oversee

implementation of this contract;

- 2.5 **Security contractor** means the successful bidder who ultimately enters into a contract and service level agreement with the Office;
- 2.6 **“Services”** means provision of physical security services in all buildings of Office OF the Premier; and

- 5.10 Describe the skill sets and competencies of your staff and resources related to this bid. List all personnel to be assigned to this service, by employer/subcontractor, identifying their qualifications to perform tasks/functions to be assigned.
- 5.11 A consortium or joint venture must submit with their bid, their consortium member partnership agreement/s that indicates their expectations of one another and their responsibilities towards one another in respect of their duties to fulfil the obligations of the consortium or joint venture in this bid. Any omission in this regard may invalidate the bid.
- 5.12 Where consortium / Joint Ventures / Sub-contract are involved; each party must be registered on the CSD, and their Tax Compliance status will be verified through the CSD.
- 5.13 Where there is a consortium / Joint Ventures, a consolidated Specific goal must be submitted.

SECTION B TERMS AND CONDITIONS

6. GENERAL TERMS AND CONDITIONS SPECIFIC TO THIS BID

6.1 OFFICIAL SUPPLY CHAIN MANAGEMENT DOCUMENTS AND FORMS

- 6.1.1 The terms and conditions specified in this bid terms of reference must be read in

conjunction with the General Conditions of Contract (GCC), which form an integral part of this bid. Prospective bidders will be well-advised to familiarize themselves with the Preferential Procurement Regulations, 2022.

6.1.2 A bidder must complete all relevant official bid forms/documents issued by the Office of the Premier, Supply Chain Management Unit and submit them as part of the bid.

6.1.3 Bidders must be registered as security service providers in terms of the **PSIRA Act**.

6.2 BID FORMAT

6.2.1 A bid must conform to or exceed the minimum requirements set out in these terms of reference. Deviations, if there are any, must be clearly stated and be substantiated with full motivations.

6.2.2 Replies to this bid must be inclusive of all requirements as stipulated at 7.4 (functional technical terms of reference of the required services).

6.2.3 Each bid proposal must be submitted in duplicate [one (01) hard copy and one (01) soft copy (memory stick with separate folders for Technical File and Price and Specific Goals File)] as indicated below:

6.2.4 Bidders are requested to initial each page of the tender document. A bid that is not accompanied by the appropriate official bid document, duly filled in and signed by the bidder, where this is necessary, may be disqualified.

6.2.5 All documents, including binders, submitted in response to this bid will become the property of the Office unless a bidder expressly indicates otherwise. Intellectual property rights contained in the information in the bid, which has been indicated as such, shall remain vested in the bidder. Any confidential information which must be respected by the Office must be indicated expressly as such for non-disclosure purposes.

6.3 VALIDITY PERIOD OF BIDS

6.3.1 Bids shall be valid for a period of 120 days (4 months) calculated from the closing date of this bid.

6.3.2 In addition, all prices quoted in a bid pertaining to support and training must remain valid and firm for the period of the contract.

6.4 FUNCTIONAL TECHNICAL TERMS OF REFERENCE OF THE REQUIRED SERVICE

6.4.1 PROCUREMENT LEGISLATION

Office of the Premier has detailed evaluation methodology premised on Treasury Regulation 16A.3 promulgated under Section 76 of the Public Finance Management Act, 1999 (Act No. 1 of 1999), the Preferential Procurement Regulations, 2022 issued

in terms of the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and the Broad Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003).

6.4.2 TECHNICAL LEGISLATION AND STANDARDS

Bidder(s) should be cognisant of the legislation and /or standards specifically applicable to the services.

6.4.3 SCOPE OF SERVICES

6.4.4 MINIMUM COMPETENCIES OF THE BIDDER

6.4.4.1 Bidders must be registered as security service provider in terms of the PSIRA Act.

6.4.4.2 Bidders must be in good standing with PSIRA and remain so for the duration of contract.

6.4.4.3 Bidders must have the infrastructure and performance capacity contemplated in Regulation 5 of the PSIRA Regulations, read with section 23(2)(b) of the PSIRA Act. **The premises of the bidders will be inspected to verify compliance.**

6.4.5. SECURITY OFFICERS MINIMUM COMPETENCIES

6.4.5.1 Security officers employed by the bidder or contemplated to be employed by the bidder to execute this contract must be registered as security service providers in terms of the PSIRA Act and Regulations and remain so registered for the duration of the contract. The Office reserves the right to ascertain this registration status at any time before or during the term of the contract.

6.4.5.2 **All security officers must -**

- a. be adequately trained in security procedures, electronic access control devices or equipment, health and safety, customer service, use of security-related equipment, search procedures, radio speech, and other security related competencies necessary for the provision of the services to the Office;
- b. be suitably qualified and capable of performing all assigned duties;
- c. have a good knowledge and understanding of their post descriptions and duties; and
- d. have undergone and passed formal, recognised and accredited security training.

6.4.5.3 Security Officers must always be professional, courteous, dedicated, and helpful.

6.4.5.4 Security Officers must not lounge around, argue, eat, smoke or drink whilst undertaking duties or attending people.

6.4.5.5 In executing the contract, Security Officers and the Security Contractor may become privy to certain privileged information of or about the Office. The Security Contractor and Security Officers must observe confidentiality and not use any information obtained pursuant to this contract for any reason other than for reasons envisaged in this contract. The Security Contractor must have systems in place to monitor compliance in this regard.

- 6.4.5.6 The Security Contractor and Security Officials must not provide any information relating to the Office to the public or news media.
- 6.4.5.7 The Security Contractor must allocate security officials who are security vetted (criminal record checks).
- 6.4.5.8 Security Officers must -
- a. not access any prohibited area;
 - b. Conspicuously wear two identification cards, one of the security contractor and the other a PSIRA issued identification card;
 - c. wear appropriate, neat, corporate uniform, which must comply with PSIRA security uniform requirements;
 - d. keep the grounds and area occupied by them clean, hygienic and neat at all times;
 - e. not carry on any trading on the sites;
 - f. immediately leave the sites upon relief by next shift security officers; and
 - g. be familiar with the Emergency Plan of the Office.
- 6.4.5.9 The Security Contractor must provide each security officer on duty with a pocket book, which security officers must carry at all times, whenever on duty.
- 6.4.5.10 The Security Contractor must, at its cost -
- a. provide regular, customized accredited training to ensure that Security Officers are able to provide the required services; and
 - b. prior to implementing any training, prepare a training plan and forward to the security administrator for approval.

6.4.6 DOCUMENTATION AND INFORMATION REQUIRED

- 6.4.6.1 A valid PSIRA Business Registration Certificate.
- 6.4.6.2 A valid PSIRA certificate of good standing.
- 6.4.6.3 PSIRA grade B registration certificates for all individuals constituting the bidding entity i.e. directors, members, partners, trustees, administrators if the applicant

is a foundation, or any person performing executive or management functions of the bidder.

- 6.4.6.4 Proof of registration with the Unemployment Insurance Fund.
- 6.4.6.5 Proof of registration with the Compensation Commissioner in terms of the Compensation for Occupational Injuries and Diseases Act, 1993 (Act No.130 of 1993).
- 6.4.6.6 Proof of registration with the Private Security Pension Fund and proof that member contributions are up to date.
- 6.4.6.7 Certified copies of bidder's firearm licenses.
- 6.4.6.8 Certified copy of Company Registration Certificate (CIPC document)
- 6.4.6.9 A brochure of the bidder's security uniform.
- 6.4.6.10 If the bidder is –
 - a. a Close Corporation or Company, CIPC Registration documents reflecting the latest information about the bidder may be attached;
 - b. a trust, a copy of the trust deed and where applicable, a letter of authorisation issued by the Master of the High Court; or
 - c. any other entity, documentation establishing that entity.
- 6.4.6.11 Completed and signed bid documents.
- 6.4.6.12 A detailed profile of the bidder, which must include detailed information on the experience of the bidder in rendering security services.
- 6.4.6.13 Bidders must disclose the following information:
 - a. Full names of persons involved in the ownership and management of the Bidder.
 - b. Details of any association or relationship between the bidder and any other bidder(s) who bid for this contract.
 - c. Details of any association or relationship between any natural person (Individual) in any way involved or associated with the bidder, and any other bidder(s) who bid for this contract.
- 6.4.6.14 Bidders must indicate–
 - a. the extent of resources under their control and resources available to enable them to execute the contract;

- b. that they will be able to adhere to generally accepted levels of quality in the provision of the service and explain the mechanism for quality assurance and review;
- c. the number and value of other contracts being undertaken by them at the date of the bid to enable the accounting officer to ascertain their ability to execute this contract;
- d. the number of full-time employees employed by the bidder at the time of bidding;
- e. a breakdown in terms of race and gender at top and middle management levels;
- f. the level of control that Historically Disadvantaged Individuals possess in the bidding enterprise as well as their involvement in the operational and management levels;
- g. the extent of black ownership at equity level; and
- h. the extent to which the bidder has invested a percentage of its turnover on projects that have an economic value on any community in the province.

6.4.6.15 Bidders must submit a detailed project plan that specifies days and times of rendering the services as specified in this document.

6.4.7 COMPLIANCE WITH LEGISLATION

6.4.7.1 The security contractor is expected to be familiar with and comply with legislation and policies applicable to the security services industry and this contract, including but not limited to-

- a. Private Security Industry Regulatory Act, 2001 (Act No. 56 of 2001);
- b. PSIRA Regulations;
- c. Code of Conduct for Security contractors issued in terms of the Private Security Industry Regulatory Act, 2001 (Act No. 56 of 2001);
- d. Control of Access to Public Premises and Vehicle Act, 1985, (Act No. 53 of 1985);

- e. Criminal Procedure Act, 1977 (Act No. 51 of 1977), in so far as it relates to execution of this contract by the bidder;
- f. Firearms Control Act, 2000 (Act No. 60 of 2000);
- g. Protection of Information Act 1982, (Act No. 84 of 1982);
- h. Trespass Act, 1959 (Act No. 6 of 1959);
- i. Occupational Health and Safety Act, 1993 (Act No. 85 of 1993);
- j. Sectoral Determination in respect of the Private Security Sector issued in terms of the Basic Conditions of Employment Act, 1997 (Act No.75 of 1997); and
- k. Labour Relations Act, 1995 (Act No.66 of 1995);
- l. Compensation for Occupational Injuries and Diseases Act, 1993 (Act No.130 of 1993);
- m. The Security Policy of the Limpopo Office of the Premier;
- n. Minimum Physical Security Standards (M.P.S.S) and Minimum Information Security Standards (M.I.S.S); and
- o. Safety at Sport and Recreational Activities Act, 2010 (Act No. 2 of 2010).

6.4.7.2 The Security Company must remain in good standing with PSIRA for the duration of the contract term, and the Office reserves the right to check the PSIRA status at any time.

6.4.8 KEY DELIVERABLES

6.4.8.1 The successful bidder will be expected to-

- a. provide access and egress control services at the sites;
- b. prevent unauthorised access and egress of persons, vehicles, assets, and any other prohibited unauthorised goods or objects;
- c. safeguard the property of the Office at the sites;
- d. provide parking management services;

- e. provide patrol services;
- f. notify the Office of any impending security threat at the sites;
- g. inform the Office of any security related incident at the sites;
- h. assist in investigations pertaining to all security issues at the sites;
- i. continually assess the security condition of the Office and recommend any necessary corrective action;
- j. when required, provide additional physical security services (per contingency plan);
- k. keep and maintain various security registers prescribed by the Office; and
- l. provide any other physical security related service.

6.4.8.2 The security contractor is expected to provide operational plan in respect of the key deliverables contemplated in clause 6.4.8.1 above.

6.4.8.3 The service contractor must assign an operational manager to the Office for the duration of the contract. The operational manager must be available on a 24 hours basis and respond immediately when needed.

6.4.8.4 The security contractor must be affiliated to the South African Police Service Communication and Crime Combating Partnership.

6.4.9 DELIVERIES

Security Officers may not accept any delivery on behalf of the Office, or any employee of the Office.

6.4.10 THIRD PARTY LIABILITY COVER

6.4.10.1 The security contractor must, at its own expense –

- a. take out valid, adequate third party liability cover specifically relating to the rendering of services in terms of this contract with an authorized financial services provider, for an amount not less than one million rand;
- b. file proof of –

- i. such cover, which must be valid for the duration of the contract with the Office on commencement date of contract;
- ii. payment of premiums as and when required by the Office.

6.4.11 OCCURRENCE BOOK

6.4.11.1 The service contractor must, at its own cost, provide, keep and maintain an occurrence book, which the Office may inspect at any time.

6.4.11.2 All incidents relating to security must be recorded in the occurrence book.

6.4.11.3 Incident reports must have a corresponding occurrence book reference number.

6.4.11.4 Any verbal instruction given to a security officer by the Office must be recorded in the Occurrence Book by the security officer.

6.4.11.5 The Occurrence Book must remain the property of the Office.

6.4.12 SITES VISITS BY SUPERVISOR

The security contractor must ensure that a supervisor conducts regular sites visits per shift. Such visits must be logged in the occurrence book.

6.4.13 MONTHLY REPORTS

The Security contractor must, on or before the last day of each month, prepare and submit a monthly report on the implementation of the contract, which must also include a consolidated list of occurrences.

6.4.14 EQUIPMENT REQUIRED

6.4.14.1 Bidders must have the following equipment, which must be made available for inspection by the Office during the evaluation and adjudication process.

N.B: items mentioned above if not provided as specified above, the contract will be terminated immediately.

6.4.14.2 The Security Contractor will be required to supply, maintain and operate, for his own account, the above equipment, which must be in good condition and functional at all times.

6.4.14.3 Each security officer on duty must be provided with a Pocket Notebook and a pen to record any incident before the incident is recorded in the occurrence book.

6.4.15 GENERAL

6.4.15.1 The Office reserves the right to order the removal of any security officer whose performance is not satisfactory to the Office.

6.4.15.2 Security officers must report for work on time and for a particular shift.

6.4.15.3 Security officers may not leave their posts without being properly relieved.

6.4.15.4 The security contractor must ensure that security officers engaged by the security contractor do not in any way cause disruptions or picket at the sites.

6.4.16 FIRE MANAGEMENT

6.4.16.1 Where security officer(s) on duty detect a fire, they must immediately inform the nearest Fire Brigade, the South African Police Services, Security Management Unit and any other emergency service authority.

6.4.16.2 Such incidents must be recorded in detail in the occurrence book.

6.4.16.3 The security contractor must give a detailed, written report to the security administrator within twelve hours of any such incident.

6.4.17 CONTINGENCY PLAN

6.4.17.1 Bidders must submit a detailed contingency plan as per the requirements set out in **Annexure B**.

6.4.17.2 Should the Office require additional security officers in terms of the contingency plan contemplated in clause 6.4.17.1, the security contractor must be able to provide the same within the period stipulated by the Office.

6.4.17.3 The security contractor must be able to provide contingency security officers in the event where any security official, for any reason, is unavailable to perform his or her duties on any given shift.

6.4.17.4 The provision of contingency security officers triggered by situations envisaged in the contingency plan contemplated in 6.4.17.1 above, will be at the cost of the security contractor and the security contractor must take this into account in compiling its bid price.

6.5 BID PRICE AND PRICE SCHEDULES

- 6.5.1 The bidder must submit a cost breakdown/s or price schedule which must indicate in detail, per product or service, and per item on 6.4 to ensure that the total cost is provided for over a period of thirty-six (36) months.
- 6.5.2 The bidder must prepare a cost breakdown/s or price schedule which must be signed by the authorized signatory, indicating costs per month, including contingency costs and total price for the duration of the contract. Failure to comply with this requirement will result in disqualification of the bid.
- 6.5.3 All prices must be in South African currency and must include Value Added Tax (VAT), contingency costs and any other additional cost.
- 6.5.4 All prices should remain firm for the contract duration. It is the responsibility of the Bidder to consider all costs and all possible escalations when compiling bid prices. Once the bid is awarded, no request for price escalation (excluding statutory wage increases as determined by the Minister) will be entertained, regardless of the reasons for such request.
- 6.5.5 A bidder must specify details of any discounts of listed prices that have been considered in the calculation of prices.
- 6.5.6 The price schedule must make provision for the costs for workshops, travelling, client meetings and refresher training sessions as set out in the training plan. The Service Provider cannot approach the Office for any additional payments in respect thereof.
- 6.5.7 The price schedule must be submitted in a separate and sealed envelope, but be included in the bid package.

6.6 PAYMENT CONDITIONS

- a. The Service Provider must submit an invoice for any payment to be made, subject to paragraphs (d) and (f) of clause 6.6, all invoices shall only become payable 30 days after receipt by the Office.
- b. No interest shall be payable in the event of a dispute nor accrue on any payments due during a period of dispute.
- c. Subject to paragraphs (d) and (f) of clause 6.5, the Office will pay the Service Provider, within thirty days of the Service Provider submitting

an invoice for payment as follows:

Monthly costs in respect of the services rendered over a period of thirty-six (36) months. These monthly costs are inclusive of the costs as per services acquired under 6.5. The Service Provider may not approach the Office for any additional payments in respect thereof.

- d. Payment is—
 - (i) subject to the satisfactory discharge of all obligations of Service Provider and delivery of the services to the Office in terms of the contract. The Office will not make payment to the Service Provider in the event the Service Provider fails to satisfactorily perform any of its obligations in terms of the contract; and
 - (ii) fixed for the duration of the contract, and the Service Provider may under no circumstances approach or request the Office for an increase in the contract price.
- e. Payments will be made by an electronic transfer, into the Service Provider's bank account as appearing on the verified CSD report and invoice of that Service Provider;
- f. The Office may withhold, deduct or set off from any monies due and owing to the Service Provider either in terms of this contract or any other contract that the Service Provider may have with the Limpopo Provincial Administration an amount equal to the amount of any outstanding claims that the Office may have against the Service Provider for damages, costs or any other indebtedness arising out of this contract: Provided that the Office will provide the Service Provider with written notice of its intention to offset, supported by reasonable detail of the actual damages, costs or indebtedness incurred by the Office. A certificate of indebtedness signed by the Chief Financial Officer of the Office, reflecting the amount due and payable shall be sufficient and conclusive proof of the contents and correctness thereof for the purposes of with-holding, deduction or set off by the Office or payment by the Service Provider or for provisional sentence, summary judgement or any other proceedings against the Service Provider in a court of law and shall be valid as a liquid document for such purposes.

- g. In the event that the Office institutes legal action against the Service Provider for any matter in connection with the contract, the Service Provider will be liable to pay the Office's legal fees on an Attorney and own client scale.

6.7 AVAILABILITY OF FUNDS

- 6.7.1 Should funds no longer be available to pay for the execution of the services, the Office may terminate this Agreement in its own discretion or temporarily suspend all or part of services by notice to the bidders, which shall immediately make arrangements to stop the performance of the services and minimize further expenditure: provided that the bidder shall thereupon be entitled to payment in full for the service delivered, up to the date of cancellation.

6.8 PRIME CONTRACTOR RESPONSIBILITIES

- 6.8.1 In the event of a consortium or joint venture bid, a prime contractor is required to take charge of the entire project and to provide a single interface between the bidder and the LPA. Therefore, in the event of a consortium or joint venture bid, one of the bidders should be designated as the prime contractor. The prime contractor shall assume total responsibility for the implementation and support of the contact centre service solution proposal, regardless of any sub-contracting agreements entered into by and amongst the consortium or joint venture parties and regardless of any agreements entered by any of the consortium or joint venture parties with a third party outside the consortium or joint venture.
- 6.8.2 The Office shall have the right to have insight at any time into any agreement or contract entered by the successful bidder. It should be indicated expressly whether such access will be granted or not.

6.9 CONTRACTUAL IMPLICATIONS

- 6.9.1 **Bid Acceptance**

The preferred bid will be accepted subject to the condition that the preferred bidder signs a contract and service level agreement prepared by the Office within seven (7) days of the conditional award. This bid, together with its terms, conditions and terms of reference, the bid response (excluding the bidder's own terms and conditions), and the GCC will form part of the contract between the Office and the successful bidder.

6.9.2 The contract or agreement or any part thereof shall not be subcontracted or sublet by the bidder to any other party without the prior written consent of the Accounting Officer of the Office after the bid has been awarded. In the event of any sub-contracting, the bidder shall bear full responsibility for the quality of work carried out by a sub-contractor, for the quality of products used by the sub-contractor, and for on the Office premises activities of the sub-contractor.

6.9.3 The bidder shall not, after the bid has been awarded, assign nor cede the contract or agreement or any part thereof or any interest therein to any other party without the prior written consent of the Accounting Officer of the Office.

6.9.4 Variations and amendments to the contract shall be valid only if they are done in writing and by mutual consent.

6.9.5 Any contract or agreement between the Office and the successful bidder shall be governed by the laws of the Republic of South Africa.

6.10 PROTECTION OF GOVERNMENT INFORMATION

6.10.1 The bidder hereby agrees and undertakes to abide by and adhere to government legislation, regulations and directives dealing with the protection of government information as if such legislation, regulations and directives apply to the bidder, and that all reasonable steps shall be taken to ensure that persons under the management of the bidder who will be engaged in the fulfilment of the bidder's contractual obligations are aware of these statutory requirements, and that these statutory stipulations will continue to apply to them even after termination of the contract or agreement or termination of their services with the bidder.

6.10.2 The entity will be vetted as well as its staff, contractors, agents and their associates, and the cooperation and facilitation of the bidder in this regard is a

condition of this bid.

6.11 CONFLICT, CORRUPTION AND FRAUD

6.11.1 The bidder shall always during the continuance of this contract use their best endeavours to ensure that no action is taken by themselves, their personnel, agents, and sub-contractors which could or might result in or give rise to the existence of conditions which are prejudicial to or are in conflict with the best interests of the Limpopo Provincial Administration.

6.11.2 The Office reserves its rights to disqualify any bidder who either itself or any of whose members (save for such members who hold a minority interest in the bidder through shares listed on any recognised stock exchange), indirect members (being any person or entity who indirectly hold at least a 15% interest in the bidder other than in the context of shares listed on a recognised stock exchange), directors or members of senior management, whether in respect of the Office or any other government organ or entity and whether from the Republic of South Africa or otherwise ("Government Entity"):

- a. engage in any collusive tendering, anti-competitive conduct, or any other similar conduct, including but not limited to any collusion with any other bidder in respect of the subject matter of these terms of reference;
- b. seeks assistance, other than assistance officially provided by a Government Entity, from any employee, advisor or other representative of a Government Entity in order to obtain any unlawful advantage in relation to procurement of services provided or to be provided to a Government Entity;
- c. makes or offer any gift, gratuity, anything of value or other inducement, to any of Office's officers, directors, employees, advisors or other representatives;
- d. makes or offers any gift, gratuity, anything of any value or other inducement, to any Government Entity's officers, directors, employees, advisors, or other representatives in order to obtain any unlawful advantage in relation to procurement or services provided or to be provided to a Government

Entity;

- e. accept anything of value or an inducement that would or may provide financial gain, advantage or benefit in relation to the procurement of services provided or to be provided to a Government Entity;
- f. pays or agrees to pay to any person any fee, commission, percentage, brokerage fee, gift or any other consideration, that is contingent upon or results from, the award of any tender, contract, right or entitlement which is in any way related to procurement or the rendering of any services to a Government Entity;
- g. has in the past engaged in any matter referred to above; or
- h. has been found guilty in a court of law on charges of fraud and /or forgery, regardless of whether or not a prison term was imposed and despite such bidder, member or director's name not specifically appearing on the list of Tender Defaulters kept at National Treasury.

6.11.3 Bidders must not have or undertake duties or interests that create or might reasonably be anticipated to create an actual or perceived conflict with its duties and interests in executing the contract. Bidders must identify any potential conflicts and bring them to the attention of the Office.

6.12 SPECIAL CONDITIONS OF THIS BID

6.12.1 Bidder's own terms and conditions or qualification of bid

This document contains the terms and conditions of this terms of reference, and bidders must not qualify the terms of reference or generate their own terms and conditions. If a Bidder does this, that bid may be disqualified.

6.12.2 The successful Bidder must–

- a. comply with all the terms of reference and standards outlined in this bid;
- b. comply with all legislation, SANS and best industry practices applicable to the successful bidders and the rendering of the services;
- c. use and adopt reasonable professional techniques and standards in providing the service;

- d. monitor project implementation against set targets, costs and time frames;
- e. provide the services with all due care, skill and diligence;
- f. ensure continuity of services to the Limpopo Provincial Administration;
- g. execute the contract under the supervision of the operational manager and comply with any directive of the operational manager;
- h. ensure that key personnel, its employees or engagement partners observe confidentiality and do not use any information obtained pursuant to this contract for any reason other than for the proper discharge of the bidder's obligations under this contract. The bidders must have systems in place to monitor compliance in this regard;
- i. obtain the signature of the operational manager on all documents or reports submitted by the successful bidders to the Office;
- j. appoint a project manager, who must, in addition to managing the project, serve as a single point of contact between the Office and the successful bidder;
- k. ensure that its employees involved in the execution of the contract are suitably qualified, properly skilled, experienced, trained, and competent to render the services. The Office may interview any person appointed by the successful bidder to execute the contract to test their understanding of the key deliverables in terms of the contract;
- l. ensure that it has all the resources necessary to fulfil its obligations in terms of the contract and will not be entitled to any resources from the Office to assist it in fulfilling its obligations;
- m. ensure that it does not, in the process of fulfilling its obligations in terms of the contract, use any labour or intellectual capacity of any employee of the state, including employees of the Office, for remunerative purposes, unless such employee has the necessary written authorisation;
- n. upon notice by the Office, revise or amend any report that the Office is not satisfied with, within a time period specified by the Office in that notice; and
- o. immediately upon receipt of a notice from the Office, promptly re-execute any portion of the services that are found to be in non-conformity with the contract. The successful Bidder is liable to the Office for any other cost,

damages or losses incurred or suffered by the Office as a result of such non-conformity.

6.12.3 RESERVATION OF RIGHTS:

The Office reserves the right to—

- (a) invite bidders to make presentations regarding any aspect (s) of the bid;
- (b) request further information or document(s) from any bidder after closing date;
- (c) verify information and documentation of any Bidder;
- (d) carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the services offered by the bidder(s), whether before or after adjudication of the Bid;
- (e) award the bid to a bidder who did not score the highest points, in terms of the PPPFA;
- (f) accept part of a tender rather than the whole tender;
- (g) not make an award;
- (h) enter into price negotiations with the preferred bidder;
- (i) cancel and/ or terminate the tender process at any stage, including after the closing date and/or after presentations have been made, and/or after tenders have been evaluated and /or after the preferred bidder(s) have been notified of their status as such; and
- (k) appoint a third party to evaluate the bidder's compliance with any aspect of this contract.

6.12.4 COSTS INCURRED BY BIDDER

6.12.4.1 The Office will not be responsible for or pay any expenses or losses which may be incurred by the bidders in the preparation, submission or presentation of its bid.

6.12.5 BID BINDING UPON SERVICE PROVIDER

All written information, warranties and representations made by or on behalf of the bidder before the conclusion of the contract are binding upon the bidders and are deemed to have induced the Office to award the contract to the Service

Provider. The Office's rights in terms of this clause are in addition and without prejudice to any other rights, it may have in terms of this contract.

6.12.6 LIABILITY

The Service Provider is responsible and liable for-

- a. the conduct, acts and omissions of its employees and the Service Provider's agents or representatives. The Service Provider indemnifies the Office against any claims whatsoever arising from its conduct and or the conduct of its employees, representatives or agents; and
- b. injury to any person, loss or damage suffered by the Office, which is occasioned by any unauthorized act, omission, negligence, breach of this contract or breach of any legislation or statutory duty by the Service Provider or the Service Provider's employees, agents or representatives. Under such circumstances, the service provider must, at its own expense, make good the loss or damage on demand and on the terms of the Office.
- c. the conduct, acts and omissions of security officers and the security contractor's agents or representatives;
- d. any unauthorized or unlawful entry by any person into the sites; and
- e. Injury to any person, theft, loss or damage suffered by the Office, which is occasioned by any unauthorized act, omission, negligence, breach of this contract or breach of any statutory duty by the security contractor or the security contractor's employees, security officers, agents or representatives. Under such circumstances, the security contractor must, at its own expense, make good the loss or damage on demand and on the terms of the Office.

6.12.7 WARRANTIES AND REPRESENTATIONS

- 6.12.7.1 Software developed, installed, configured, tested, and commissioned by the successful bidder, their personnel, agents or sub-contractors shall be free of technical defects or bugs and shall be so guaranteed for the period of the contract, calculated from the date of acceptance of the service by the Office.

Any defects or bugs which are attributable to poor workmanship or negligence on the part of the bidder, which come to the notice of the Office, and to which the Office draws the attention of the bidder, shall be rectified by the bidder at the bidder's own cost and time. Any rectification shall be guaranteed for a further period of 12 months. After the expiry of the warranty period all charges relating to correction of technical defects or bugs shall be expressly and distinctly denoted as such on any billing documentation.

6.12.7.2 The Service Providers warrants that-

- a. the Service Provider has the capacity and resources to render the services as specified;
- b. on delivery of the services, the services will be suitable for the purpose stipulated in this contract;
- c. the services will comply with these terms of reference. Any unilateral departure by the Service Provider from such term of reference or standards is breach of this contract;
- d. no fact or circumstances exist that may materially affect its capacity to perform its obligations under this contract;
- e. the Service Provider will not use any labour or intellectual capacity of any employee of the State, (including the Office) for remunerative purposes, except where the employee of the State has the necessary permissions in terms of applicable laws, in which event proof of such permissions must be hand-delivered to the Office at the address for service, on date of signature by the Service Provider of this contract, and an acknowledgement of receipt be obtained by the Service Provider.
- f. it is the owner of, or has a good title to all services delivered in terms of this contract; and
- g. it shall at all times have and comply with all legal requirements and with the terms and conditions of all necessary licences, certificates, authorisations and consents required under the laws of the Republic of South Africa or under any other applicable jurisdiction for the delivery of services.

6.12.8 TERMINATION OF CONTRACT

6.12.8.1 Bidders must acquaint themselves with the provisions of section 30 of the Public Service Act, 1994 (Proclamation 103 of 1994), and ensure that where applicable, natural persons who constitute the bidders comply with the Act. The Office reserves the right to disregard a bid or cancel the contract with the bidder or service provider-

- a. has failed to comply with any legal or policy requirement in order to enter into a valid contract with the Office, including but not limited to any public servant constituting or in the employ of the bidder or service provider not having the necessary permissions or authorisation in terms of the Public Service Act, or not having made the necessary financial disclosures to the employer or not having declared any or all interests in the bid documents;
- b. has acted in a fraudulent manner or in bad faith or in any other unsatisfactory manner in obtaining any other contract with any state institution, government department, provincial administration or public entity;
- c. after notification that the bid has been conditionally accepted, either fails, refuses or neglects or causes undue delays in the signing of the contract and service level agreement prepared by the Office;
- d. has entered into any arrangement or agreement with any other natural or corporate person, whether legally binding or not, to-
 - i. refrain from bidding for this contract; or
 - ii. bid at an agreed price.
- e. breaches any applicable SANS, legislation or policy.

6.12.8.2 The Office may immediately terminate the contract without any notice to the Service Provider if any of the following circumstances occur or exist:

If the Service Provider –

- a. commits an act of professional misconduct or professional or technical incompetence, which is substantial and serious;

- b. commits or participates in any unlawful, dishonest or unethical act in the performance of its obligations under this contract; or
- c. breaches this contract twice during the contract period (including failure to provide items specified in table 2)

6.13 PRECEDENCE

6.13.1 This document will prevail over any information provided during any briefing session whether oral or written, unless such written information provided, expressly amends this document by reference.

6.14 TAX COMPLIANCE

6.14.1 Bidder(s) must be tax compliant when submitting a bid to the Office and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and the Valued Added Tax Act, 1991 (Act No. 89 of 1991).

6.14.2 It is a condition of this bid that the tax matters of the successful bidder(s) be in order, or that satisfactory arrangements have been made with the South African Revenue Service (SARS) to meet the bidder's tax obligations.

6.14.3 The tax compliance status requirements are also applicable to foreign bidders/ individuals who submit bids.

6.14.4 Bidders are required to be registered on the CSD and the Office shall verify the bidder's tax compliance status through the CSD.

6.14.5 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database

8.2 Gate 1: Technical Evaluation Criteria = 100 points

All bidders are required to respond to the technical evaluation criteria.

Only Bidders that have met the **Pre-Qualification Criteria** will be evaluated in **Gate 1** for functionality. Functionality will be evaluated—:

- i. In accordance with the Evaluation Criteria for technical functionality listed in Annexure A
- ii. out of 100 points Bidders are required to achieve a minimum threshold of **75** points to proceed to **Gate 2 for Price and Specific goals evaluations**.

b. Joint Ventures, Consortium and Trusts

A trust, consortium or joint venture, will qualify for points for their Specific goals as a legal entity, provided that the entity claims the points and submits proof where necessary.

A trust, consortium, or joint venture will qualify for points for its Specific goals as an unincorporated entity, provided that the entity submits its consolidated Specific goals

scorecard as if it were a group structure and such a consolidated Specific goals scorecard is prepared for every separate bid.

Bidders must submit concrete proof of the existence of joint ventures and/or consortium arrangements. The consortium or joint venture agreement must be legally compliant with the laws applicable to such consortium or joint venture agreement. The Office will accept signed agreements as acceptable proof of the existence of a joint venture and/or consortium arrangement.

The joint venture and/or consortium agreements must clearly set out the roles and responsibilities of the Lead Partner (Prime Contractor) and the joint venture and/or consortium party.

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- The General Conditions of Contract will form part of all bid documents and may not be amended.
- Special Conditions of Contract (SCC) relevant to a specific bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

- 1.12 "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 "GCC" means the General Conditions of Contract.
- 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 "Project site," where applicable, means the place indicated in bidding documents.
- 1.21 "Purchaser" means the organization purchasing the goods.
- 1.22 "Republic" means the Republic of South Africa.
- 1.23 "SCC" means the Special Conditions of Contract.
- 1.24 "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.

- 1.25 “Written” or “in writing” means handwritten in ink or any form of electronic or mechanical writing.
- 2. Application**
- 2.1 These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2 Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3 Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.
- 3. General**
- 3.1 Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2 With certain exceptions, invitations to bid are only published in the Government Tender Bulletin. The Government Tender Bulletin may be obtained directly from the Government Printer, Private Bag X85, Pretoria 0001, or accessed electronically from www.treasury.gov.za
- 4. Standards**
- 4.1 The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.
- 5. Use of contract documents and information; inspection.**
- 5.1 The supplier shall not, without the purchaser’s prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only so far as may be necessary for purposes of such performance.
- 5.2 The supplier shall not, without the purchaser’s prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.
- 5.3 Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier’s performance under the contract if so required by the purchaser.
- 5.4 The supplier shall permit the purchaser to inspect the supplier’s records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.
- 6. Patent rights**
- 6.1 The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 7. Performance**
- 7.1 Within thirty (30) days of receipt of the notification of contract award,

security

the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.

7.2 The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.

7.3 The performance security shall be denominated in the currency of the contract, or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:

(a) a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or

(b) a cashier's or certified cheque

7.4 The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

8. Inspections, tests and analyses

8.1 All pre-bidding testing will be for the account of the bidder.

8.2 If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the Department or an organization acting on behalf of the Department.

8.3 If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.

8.4 If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the supplies to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.

8.5 Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.

8.6 Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

8.7 Any contract supplies may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies shall be held at the

cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier.

8.8 The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.

9. Packing

9.1 The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.

9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, if any, specified in SCC, and in any subsequent instructions ordered by the purchaser.

10. Delivery and documents

10.1 Delivery of the goods shall be made by the supplier in accordance with the terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified in SCC.

10.2 Documents to be submitted by the supplier are specified in SCC.

11. Insurance

11.1 The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.

12. Transportation

12.1 Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.

13. Incidental services

13.1 The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC:

- (a) performance or supervision of on-site assembly and/or commissioning of the supplied goods;
- (b) furnishing of tools required for assembly and/or maintenance of the supplied goods;
- (c) furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
- (d) performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties,

- provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
- (e) training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.

13.2 Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

14. Spare parts

14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:

- (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and
- (b) in the event of termination of production of the spare parts:
 - (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
 - (ii) following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

15. Warranty

15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.

15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.

15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.

15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser

may have against the supplier under the contract.

- 16. Payment**
- 16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC.
- 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier.
- 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.
- 17. Prices**
- 17.1 Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
- 18. Contract amendments**
- 18.1 No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
- 19. Assignment**
- 19.1 The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
- 20. Subcontracts**
- 20.1 The supplier shall notify the purchaser in writing of all subcontracts awarded under this contracts if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.
- 21. Delays in the supplier's performance**
- 21.1 Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2 If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3 No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.
- 21.4 The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily

available.

21.5 Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties.

21.6 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without canceling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

22. Penalties

22.1 Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

23. Termination for default

23.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:

- (a) if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
- (b) if the Supplier fails to perform any other obligation(s) under the contract; or
- (c) if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.

23.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.

23.3 Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.

23.4 If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the

envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the intended penalty as not objected against and may impose it on the supplier.

23.5 Any restriction imposed on any person by the Accounting Officer / Authority will, at the discretion of the Accounting Officer / Authority, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the Accounting Officer / Authority actively associated.

23.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:

- (i) the name and address of the supplier and / or person restricted by the purchaser;
- (ii) the date of commencement of the restriction
- (iii) the period of restriction; and
- (iv) the reasons for the restriction.

These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.

23.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

24. Anti-dumping and countervailing duties and rights

24.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him

- 25. Force Majeure**
- 25.1 Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.
- 25.2 If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.
- 26. Termination for insolvency**
- 26.1 The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.
- 27. Settlement of Disputes**
- 27.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4 Mediation proceedings shall be conducted in accordance with the rules of procedure specified in the SCC.
- 27.5 Notwithstanding any reference to mediation and/or court proceedings herein,
- (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- (b) the purchaser shall pay the supplier any monies due the supplier.
- 28. Limitation of liability**
- 28.1 Except in cases of criminal negligence or willful misconduct, and in the case of infringement pursuant to Clause 6;
- (a) the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and

- (b) the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.
- 29. Governing language** 29.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
- 30. Applicable law** 30.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified in SCC.
- 31. Notices** 31.1 Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.
- 32. Taxes and duties** 32.1 A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.
- 32.2 A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.
- 32.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid the Department must be in possession of a tax clearance certificate, submitted by the bidder. This certificate must be an original issued by the South African Revenue Services.
- 33. National Industrial Participation (NIP) Programme** 33.1 The NIP Programme administered by the Department of Trade and Industry shall be applicable to all contracts that are subject to the NIP obligation.
- 34. Prohibition of Restrictive practices** 34.1 In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder (s) is / are or a contractor(s) was / were involved in collusive bidding (or bid rigging).
- 34.2 If a bidder(s) or contractor(s), based on reasonable grounds or evidence obtained by the purchaser, has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in the Competition Act No. 89 of 1998.

- 34.3 If a bidder(s) or contractor(s), has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.
