It is a privilege and honour to welcome you to this important engagement, the Premier's Inter-Governmental Relations Forum (P-IGR). On behalf of the Premier and the Executive Council, please receive our warm greetings.

In this regard, we would like to remind this house about the national economic and social outlook, which does not show us much relief. Unemployment rate continues to rise, while the cost of living is also high.

I decided that it is crucial to single out these current challenges not because they are the only ones which are fundamental, but because I am looking at a leadership collective with capabilities to confront them head-on and emerge victorious. We have always spoken about hope, but now we have to speak about reason for that hope, we should be that reason.

Our people know very well that as their elected representatives, we have gathered here today, and they expect solutions to their current service delivery challenges from us. That is were now our generational mission comes in. We all have pledged that, we are not going to betray our mission, rather, we are going to fulfil it, as Frantz Fanon has said.

The people who elected us expect that through our dedication and commitment, they will receive clean and potable water, sustainable electricity supply, basic health care, quality education, job opportunities through stimulation of local economy, amongst others.

The late civil activist and liberation hero Moses Kotane challenged us when he said that "the future of your country is in your hands and depends on what you make of it". That moment is now.

In line with the dictates of the District Development Model our cooperation as national, provincial and local government is crucial.

Our decision to achieve all the aims and objectives of the Musina-Makhado and Fetakgomo-Tubatse Special Economic Zones still stands. On that note, we urge affected municipalities to prioritize these projects so that we will leverage the economic spin-offs associated with the SEZs.

Our resolve towards a disclaimer free audit outcome in the province is still alive. We are proud that the Auditor General in her recent interaction with the Executive

Council, singled out Limpopo as one of the best performing province in terms of qualitative audit outcomes.

Our infrastructure development programme guided by the District Development Model (DDM) as launched by President Matamela Ramaphosa is still a government programme that we need to synergise for development of local communities.

Mayors and Councillors are still expected to give regular feedback to our communities regarding service delivery issues.

Following today's meeting, all of us are expected to follow Finance Minister Mr. Enoch Godongwane, as he releases the Medium Term Expenditure Framework for the country.

All of us are still expected to embrace the Limpopo Development Plan, with all its cardinal points like, the Infrastructure Development Plan.
